



4. Results for the current reported quarter and year to date figures for the period ended 31st December, 2017 are in compliance with Indian Accounting Standards (IND AS) notified by the Ministry of Corporate Affairs read with SEBI Circular number CIR/CFD/FAC/62/2016 dated July 5, 2016.

The above referred financial results of corresponding previous quarter and year to date figures for the period ended 31st December, 2016, have not been subjected to limited review or audit further in accordance with IND AS. However, the management has exercised necessary due diligence to ensure that the financial results provide a true and fair view of its affairs.
6. The Company operates only in one business segment.
7. The above results does not include IND AS compliant results for the preceeding quarter and year ended 31st March, 2017 as the same is not mandatory as per SEBI circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.




