

election for the Lok Sabha, India's house of Parliament was the largest the world has seen. More than 100 candidates from various political parties contested for 543 seats.

'I would say from the US perspective we are very confident in the fairness and integrity of the Indian election. We will obviously work with whoever the victor and whatever the outcome there,' State Department spokesman Morgan Ortugas told reporters Wednesday.

Unlike other countries, the US does not send its election observers because of the strong independence of the Election Commission.

'We have a very strong relationship and a lot of cooperation with the government on a full range of issues,' the Secretary of State, Mike Pompeo said numerous times that we have a strategic partner in India,' Ortugas said in response to a question.

The diplomat praised Indian people for carrying out such protests and exercising peacefully, describing them as 'impressive'.
