New Delhi, Nov 7: Indian Medical Association (IMA) today declared public health emergency in Delhi, due to high pollution level. The IMA has suggested closing down of schools and urged people not to venture out.

The doctors association has also written to Delhi Chief Minister Arvind Kejriwal demanding cancellation of Airtel Delhi Half Marathon on 19 November, due to 'high level of air pollution' in the national capital.

Delhi woke up to 'severe' air quality under a blanket of thick haze, as pollution levels breached the permissible standards by multiple times.
